

BYLAW NO. 247/22

RURAL MUNICIPALITY OF MARTIN NO 122

A BYLAW TO REGULATE THE PROCEEDINGS OF MUNICIPAL COUNCIL AND COUNCIL'S COMMITTEES

The Council of the Rural Municipality of Martin No 122 in the Province of Saskatchewan enacts as follows:

PART I - INTERPRETATION

Short Title

1.1 This Bylaw may be cited as "The Council Procedures Bylaw".

2. <u>Purpose</u>

The purpose of this bylaw is to establish clear, transparent, consistent and accessible rules for conducting business at Council Meetings, Committee Meetings and Other Bodies' Meetings, as well for Council Members, administrations and the public to follow 2.1 and participate in governing the municipality.

Definitions

- 3.1 In this Bylaw:
 - "Act" means The Municipalities Act;
 - "Acting Reeve" means the Councillor elected by Council to act as the Reeve if (a) (b) a vacancy arises in that office;
 - "Adjourn" means to suspend proceedings to another time or place;
 - "Administration" means the Administrator or an employee accountable to the (c) (d) Administrator:
 - "Administrator" means the Chief Administrative Officer or person appointed as (e) Administrator pursuant to Section 110;
 - "Agenda Deadline" means the time established in Subsection 13.6 of this Bylaw;
 - "Amendment" means an alteration to a main motion by substituting, adding or (f) deleting a word or words without materially altering the basic intent of the motion; (g)
 - "Business Day" means a day other than a Saturday, Sunday or holiday;
 - "Chair" means a person who has the authority to preside over a meeting; (h) (i)
 - "Committee" means a Committee, Board, Authority or Other Body duly (j) appointed by Council;
 - "Communications" include, but are not limited to the following: letter, memorandum, report, notice, electronic mail, facsimile, petition, brochure, or (k) newspaper/magazine article;
 - "Contact Information" mean:
 - The name of the person, and
 - Whichever of the following options is considered by the sender to be most likely to affect receipt by the intended recipient:
 - (a) Mailing Address,
 - (b) Street or Civic Address.
 - (c) Email Address,
 - (d) Cell or Telephone Number,
 - (e) Fax Number
 - (f) Any other prescribed Option;
 - "Council" means the Reeve and Councillors of the municipality elected pursuant (m) to the provisions of The Local Government Election Act, 2015;
 - "Council Committee" means a Committee duly appointed by Council and (n) consisting of Council Members only;
 - "Councillor" means the Council Member duly elected in the municipality as a (0) Councillor, in accordance with The Local Government Election Act, 2015;

- "Deputy Reeve" means the Councillor who is appointed by Council, pursuant to Section 33 of this Bylaw, to act as Reeve in the absence or incapacity of the (p) Reeve:
- "Member" means the Reeve, Councillor or an appointed individual to a Committee, Commission or Board of Council; (q)
- "Motion" means a formal proposal placed before a meeting in order that it may (r) be debated to a conclusion;
- "Mover" means a person who presents or proposes a motion or amendment;
- "Municipality" means the Rural Municipality of Martin No 122; (s)
- "Order of Business" means the list of items comprising the agenda and the order in which those items appear on the agenda; (u)
- "Other Body" means a Committee, Board, Authority, Commission or Other Body duly appointed by Council, but does not include a Council Committee; (v)
- "Point of Order" means the raising of a question by a member in a meeting claiming that the procedures of the meeting or of an individual Council Member (w) are contrary to the procedural rules or practices;
- "Point of Privilege" is the raising of a matter by a member which occurs while (x) the Council is in session, where:
 - the rights, privileges, decorum or dignity of the Council collectively or the rights and privileges of a member individually have been affected,
 - when a member believes that another member has spoken disrespectfully toward them or the Council, or
 - when a member believes their comments have been misunderstood or misinterpreted by another member or members; or
 - when a member believes that comments made by the member outside the Council Chamber have been misinterpreted or misunderstood by the community, the public or the news media in order to clarify his or her
 - "Point of Procedure" means a question directed to the person presiding at a meeting to obtain information on the rules or procedures bearing on the business
 - "Public Hearing" means a meeting of Council or that portion of a meeting of Council which is convened to hear matters pursuant to: (z)
 - Section 123 of the Act
 - i. The Planning and Development Act, 2007; ii.
 - any other Act; or iii.
 - a resolution or bylaw of Council;
 - (aa) "Quorum" is, subject to Section 98 of the Act:
 - in the case of Council, a majority of the whole Council,
 - in the case of a Committee, a majority of the members appointed to the ii.
 - in the case of an Other Body, a majority of the members appointed to the
 - (bb) "Recess" means an intermission or break within a meeting that does not end the meeting, and after which proceedings are immediately resumed at the point where they were interrupted;
 - (cc) "Reeve" means the Council Member duly elected in the municipality as the Reeve in accordance with the Location Government Elections Act, 2015;
 - (dd) "Resolution" means a formal determination made by Council or a Committee on the basis of a motion, duly placed before a regularly constituted meeting or a Special Meeting of Council or a Committee for debate and decision, and is duly passed;
 - (ee) "Special Meeting" means a meeting other than a regular scheduled meeting called pursuant to Section 123 of the Act or the provisions of this Bylaw;
 - "Unfinished/Old Business" means business which has been raised at the (ff) same, or a previous meeting, and which has not been completed;
 - "Urgent Business" means a time sensitive matter which requires Council's (gg) immediate and urgent consideration;
 - (hh) "Perceived Conflict of Interest" means a circumstance where a reasonable person would believe that a conflict exists.
- A reference in this Bylaw to an enactment of the Legislative Assembly of 3.2 Saskatchewan is a reference to the enactment as amended from time to time.

4. Application

This Bylaw applies to all meetings of Council, Committees and other bodies.

Notwithstanding Subsection 4.1, Council may by resolution or bylaw allow a Council 4.1 Committee or Other Body to establish its own procedures. 4.2

When any matter relating to proceedings arise which is not covered by a provision of this Bylaw, the matter shall be decided by reference to Robert's Rules of Order. 4.3

In the event of any conflict between the provisions of this Bylaw and those contained in Subsection 4.3, the provision of this Bylaw shall apply. 4.4

Subject to Subsection 4.3, any ruling of the Reeve or chair shall prevail, subject to the jurisdiction of Council or the Council Committee to consider any appeals of those 4.5 rulings.

PART II - MEETINGS

First Meeting

The first meeting of Council shall be set by the Administrator within 31 days after the date of the election at a time, date and place determined by the Administrator.

Prior to the commencement of the first meeting, every member of Council shall take 5.2 the Oath or Affirmation of Office pursuant to the Act.

At the first meeting of Council, the Administrator shall provide Council with a copy of the Returning Officer's Declaration of Results with respect to the election. 5.3

6. Regular Meetings

Regular meetings of Council shall be held on the second Wednesday of each month 6.1 commencing at 8:00 am.

Council shall ensure that the time between regularly scheduled Council Meetings does 6.2

not exceed 60 days. In the event of any meeting date falling on a statutory or civic holiday or any day appointed as a holiday by proclamation of the Governor-General of Canada, the 6.3 Lieutenant Governor of Saskatchewan, or the Reeve, such meetings shall be held at the same time on the next day that the municipal office is scheduled to be open for

Annually, each December Council Meeting, the Administrator shall submit a regular schedule of Council Meetings to Council for approval as set out in Subsections 6.1 6.4 and 6.2, or may recommend meeting dates.

Notwithstanding the foregoing provisions, Council may, by resolution, dispense with 6.5 or alter the time of a Regular Meeting of Council.

Council may, by resolution, authorize the Reeve to reschedule a Regular Meeting of 6.6 Council pursuant to the Act during a period of time to be specified within the resolution.

7. Special Meetings

The Administrator shall call a Special Meeting of Council, whenever requested to do 7.1 so, in writing, by the Reeve or a majority of the members.

If the position of Administrator is vacant or the Administrator is unable to act, the 7.2 Council shall designate an Administrator, from any of the adjoining Municipalities, as Acting Administrator for the purpose of calling a Special Meeting of Council whenever requested to do so in writing by the Reeve or a majority of the members, pursuant to Section 81.1 of the Act.

The written request referred to in Subsection 7.1 shall include all items of business to 7.3 be transacted.

Form 1, appended hereto and forming a part of this Bylaw, shall be the form used to 7.4 direct the Administrator to call a Special Meeting of Council.

When a special meeting is to be held, the Administrator shall provide written notice of 7.5 the time, date and place of the meeting to all members pursuant to Section 10 of this Bylaw and to the public at least twenty-four (24) hours prior to the meeting and, in general terms, of the business to be transacted at the meeting.

7.6 Notwithstanding Subsection 7.4, a special meeting may be held with less than twentyfour (24) hours notice to members, and without notice to the public, if all members agree to do so, in writing, immediately before the beginning of the special meeting.

7.7 No business, other than that stated in the notice, shall be transacted at a special meeting, unless all the members are present and, by unanimous consent, they authorize other business to be transacted.



One or more members of Council may participate in a council meeting by electronic 8. Meeting through Electronic Means

(a) the members of Council provide the Administrator with at least two (2) business days' notice of their intent to participate in this manner:

(b) Notice of the Council Meeting is given to the public including the way in which the (c) the facilities enable the public to at least listen to the meeting at a place specified Council Meeting is to be conducted;

in that notice and the Administrator is in attendance at that place; and

(d) the facilities permit all participants to communicate adequately with each other

Members participating in a Council Meeting held by means of a communication facility are deemed to be present at the Council Meeting. 8.2

Notice of regularly scheduled Council Meetings is not required to be given. **Notice of Meetings**

- If Council changes the date, time or place of a regularly scheduled meeting, at least 9.1 twenty-four (24) hours' notice of the change will be given to: 9.2
 - (a) any members not present at the meeting at which the change was made; and,
 - (b) the public.

10. Method of Giving Notice

Notice of a Council Meeting is deemed to have been given to a member if the notice 10.1

(a) delivered personally;

(b) left at the usual place of business or residence of the member; or

- (c) at the request of the member, provided or sent according to the member's contact
- Form 2, appended hereto and forming a part of this Bylaw, shall be the form used to request the Administrator to use an alternate method of providing notice of meetings. 10.2
- Notice of a Council Meeting is to be given to the public by posting notice of the meeting at the Municipal Office or on the RM of Martin website (www.rmofmartin.com), or in 10.3 any other manner specified by Council through bylaw.

11. Actions in Public

- An act or proceeding of Council is not effective unless it is authorized or adopted by bylaw or a resolution at a duly constituted public meeting of Council.
- Every person has the right to be present at Council Meetings that are conducted in public unless the person presiding at the Council Meeting expels a person for improper 11.2 conduct.

12. Closed Sessions

- Council may close all or any part of its meetings to the public if the matter to be discussed:
 - (a) is within one of the exemptions of Part III of The Local Authority Freedom of Information and Protection of Privacy Act; or

(b) concerns long-range or strategic planning.

- A resolution to move into closed session shall state, in general terms, the topic of 12.2 discussion.
- Where Council resolves to close a portion of a meeting to the public, all persons shall 12.3 be excluded from the meeting except:

(a) the members of Council;

(b) the Administrator and other members of administration as the members of Council may deem appropriate; and

(c) the members of the public as the members of Council deem appropriate.

- Where Council resolves to close a portion of a meeting to the public, in addition to the 124 resolution to do so, the Administrator shall record in the minutes:
 - (a) the time that the in-camera portion of the meeting commenced and concluded;

(b) the names of the parties present; and

(c) the legislative authority including the exemptions in Part III of The Local Authority Freedom of Information and Protection of Privacy Act relied upon for authority to close the meeting to the public.

12.5 No resolutions or bylaws may be passed during a closed meeting.

No business other than that described within the resolution pursuant to Subsection 12.6 12.2 may be discussed.

Matters discussed or to be discussed in a closed meeting are to be kept in confidence 12.7 until discussed at a public meeting of Council, unless otherwise provided for in this Bylaw.

PART III - COUNCIL MEETING PROCEDURES

13. Agendas

The Administrator shall prepare the agenda for all Regular and Special Meetings of 13.1 Council.

The agenda shall include the order of business and all items of business and 13.2 associated reports, bylaws or documents and shall be set out in accordance with the order of business. In certain circumstances order of business may need to be amended to allow for time constraints, delegation attendance, vacating Council member or changes to quorum.

The Administrator shall ensure that the Council agendas are delivered to each member 13.3 no later than two (2) business days immediately preceding the Council Meeting.

The Administrator shall ensure that the Council Agendas are available to the general 13.4 public no later than one (1) business day.

If, for any reason, the Administrator is unable to meet the deadline mentioned in 13.5 Subsection 13.3, the Administrator shall prepare and distribute the agenda as soon as reasonably possible to allow Council members an opportunity to review the agenda prior to the Council Meeting.

All communication from the public, requests, or any other material intended for 13.6 inclusion in a Council Agenda must be received by the Administrator no later than two

(2) business days.

Council may, on a majority vote, permit additional material on the Agenda. 13.7

14. Urgent Business

A Council member may request to add a matter to the agenda of a meeting as urgent 14.1 business after the agenda has been prepared and distributed by the Administrator.

In these circumstances, the Council member shall submit a report to the Administrator 14.2 including an explanation of the reasons and degree of urgency of the matter as soon as possible.

The Administrator shall distribute any requests from the Council member to add a 14.3 matter of urgent business to the agenda to the members as soon as they are available.

Council may only consider a matter of urgent business by a majority vote of members 14.4 present.

15. Order of Business at Meetings

The general order of business of every Regular Council Meeting shall be as follows: 15.1

(a) Call to Order;

- (b) Delegations at a time established by Council;
- (c) Public Hearings at a time established by Council;

(d) Foreman Report;

- Approval of Minutes; (e)
- Statement of Financial Activities; (f)

(g) Accounts Payable;

- Division and Committee Reports; (h)
- Administrator's Report; (i)
- Unfinished/Old Business; (j)
- Communications/Correspondence; (k)

New Business; (1)

- (m) Notice of Proclamations;
- (n) Presentations and Recognitions;

(o) Adjournment.

The business shall, in all cases, be taken up in the order in which it stands on the 15.2 agenda, unless:

(a) the Reeve determines during the proceedings of Council that for public interest a matter be moved forward to be dealt with promptly.

16. Commencement of Council Meeting

At the hour set for the meeting, or as soon as all members of Council present, the Reeve, or in his or her absence the Deputy Reeve, shall take the chair and call the LB- QUE members to order.

In case neither the Reeve nor the Deputy Reeve is in attendance within 15 minutes after the hour appointed, and subject to a quorum being present, Council shall appoint an Acting Reeve pursuant to Section 34 of this Bylaw.

The person appointed pursuant to Section 16.2 shall call the meeting to order and shall preside over the meeting until the arrival of the Reeve or the Deputy Reeve, and 16.3 all proceedings of such meeting shall be deemed to be regular, and in full force and

effect.

If a quorum is not present 30 minutes after the time appointed for the meeting, the 16.4 Administrator shall record the names of the members present at the expiration of such time and announce that Council shall then stand adjourned until the next meeting, unless a special meeting is called in the meantime.

Subject to the Act, if at any meeting the number of members is reduced to less than 16.5

the number required for a quorum, Council shall stand adjourned.

Any unfinished business remaining at the time of the adjournment, due to the loss of 16.6 the quorum, shall be considered at the next regular meeting, or it shall be placed on the agenda for a special meeting called for the purpose of dealing with the unfinished items.

Members are encouraged to notify the Administrator when the member is aware that 16.7

he or she will be absent from any meeting of Council.

17. Quorum

A quorum of Council is a majority of members. 17.1

Any act or proceeding of Council that is adopted at any Council Meeting at which a quorum is not present is invalid.

18. Minutes

The Administrator shall record the minutes of each Council Meeting without note or 18.1 comment and shall distribute copies of the minutes to each member at least twentyfour (24) hours prior to a subsequent Council Meeting.

Notwithstanding Section 18.1, the Administrator shall record in the minutes every 182 declaration of a conflict of interest and the general nature and material details of the

disclosure and any abstention or withdrawal.

The names of the members present at the meeting are to be recorded in the minutes 18.3 of every meeting.

Any member may make a motion amending the minutes to correct any mistakes. 18.4 The minutes of each meeting are to be approved at the next regular meeting of the 18.5

Council and signed by the presiding member and the Administrator in accordance with the Act.

All minutes, once approved, shall be open for inspection to the public. 18.6

19. Proclamations

All requests for proclamations shall be submitted to the Reeve for approval, outlining the date to be proclaimed, specific name of day, week or month requested, the reason for the proclamation and information about the group, including contact person and telephone number at least fourteen (14) days prior to the proposed date for the proclamation. However, exceptions may be made in extenuating circumstances.

Subject to The Saskatchewan Human Rights Code, the Reeve may, in his or her sole 19.2 discretion, approve the proclamation submitted pursuant to Subsection 19.1, provided

the proclamation does not:

(a) promote any commercial business, unless, at the discretion of the Reeve, the Proclamation provides a significant benefit to the community;

(b) involve any person or organization which promotes hatred of any person or class of persons or otherwise involves illegal activity; or

(c) contain any inflammatory, obscene or libelous statement.

19.3 The Reeve may:

(a) issue the proclamation:

in the words and form of the proclamation as submitted; or

in words and form chosen by the Reeve; or

(b) forward the proclamation for consideration by Council.

Once the proclamation has been approved, the proclamation shall be noted on the 19.4 appropriate Council Agenda as information.

Council, having delegated the administration of proclamations, shall not hear 19.5 delegations related to proclamation requests, unless specifically approved by Council.

Each organization shall be responsible for any costs and the disseminating of the 19.6 proclamation to the media and making arrangements for the attendance of the Reeve or Councillors at the specific function or event. YE CAN



The local media are requested: 19.7

(a) not to publish any proclamation claiming to be proclaimed by the Reeve unless it bears his or her signature; and

(b) when publishing a proclamation by the Reeve, that the proclamation contains only the following:

the crest of the municipality;

- the name of the municipality; and ii.
- the text of the proclamation. iii

20. Presentations & Recognitions

Presentations shall be listed on the agenda when authorized by the Reeve and shall 20.1 be intended to recognize an individual or group on behalf of Council for some award or similar honour which they have received or for a group or individual to present to Council some award or similar honour which the municipality has been awarded.

21. Public Hearing

If a public hearing is required by any Act, it shall be conducted in accordance with the 21.1 provisions of this section.

The procedure by which the public hearing will be conducted or by which public input 21.2 will be obtained shall be as follows:

(a) the Reeve shall declare the hearing on the matter open;

(b) the administration shall present a report on the bylaw or resolution under consideration including the administration recommendations;

(c) if it is a hearing that involves an applicant, the applicant shall be given an opportunity to make representations on the matter under consideration;

(d) after the applicant, any person or group of persons or spokesperson acting on behalf of another person or group shall be given an opportunity to make representations on the matter under consideration;

(e) if it is a hearing that involves an applicant, at the conclusion of the speakers, the applicant shall be given an opportunity to respond to the representations of other people;

(f) Council may request further information from administration;

(g) Council shall formally receive all communications and written reports submitted to it on the subject matter of the hearing;

(h) the Reeve shall declare the hearing closed; and

- (i) Council shall then consider the matter and at the conclusion of the deliberations, Council shall vote on the bylaw or resolution in accordance with the procedures contained in this Bylaw.
- The time allowed for each person making representations shall be 15 minutes. 21.3

A hearing may be adjourned to a certain date. 21.4

A member shall abstain from taking part in the debate or voting on the bylaw or 21.5 resolution, which is the subject of the hearing if the member was absent from any part of the public hearing.

22. Communications - General

When a person wishes to have a communication considered by Council, it shall be addressed to Council, and:

(a) clearly set out the matter in issue and the request; and

(b) for written communications, must be printed, typewritten or legibly written, contain the mailing address of the writer and be signed with the name of the writer; or

(c) for electronic communication, must contain the name of the writer and both the mailing and electronic address of the writer.

A communication received by the Administrator, which does not meet the conditions 22.2 in subsection 22.1 or is abusive in nature, shall be forwarded to the Reeve for review and disposition.

A communication received by the Administrator which contains or relates to personal 22.3 information shall be dealt with in accordance with the provisions of The Local Authority Freedom of Information and Protection of Privacy Act.

Bound documents or studies in support of the delegation's notice shall, if sufficient 22.4 copies are provided by the delegation, be circulated to members, but will not be reproduced.

23. Communications – Matters on Council Agenda

A written communication pertaining to a matter already on a Council Agenda must be received by the Administrator no later than the agenda deadline in order to be included on the Council Agenda.



A written communication received before the agenda deadline shall be placed by the Administrator on the Council Agenda and shall be dealt with when the matter is considered by Council at its meeting.

In the event that the communication to the Administrator is received after the agenda 23.3 deadline, regarding a subject which is on the agenda, the Administrator will bring the

request to the attention of Council:

(a) The individual will be advised by the Administrator that the communication may not be considered by Council unless the majority of members vote to allow the communication within the motion to approve the agenda.

24. Communications – Matters not on Council Agenda

A written communication received before the agenda deadline shall be placed by the 24.1 Administrator on the Council Agenda and shall be dealt with when the matter is considered by Council at its meeting.

In the event that the communication to the Administrator is received after the agenda 24.2 deadline, regarding a subject which is not on the agenda, the Administrator will bring

the request to the attention of Council.

The individual will be advised by the Administrator that the communication may not be 24.3 considered by Council unless the majority of members vote to allow the communication within the motion to approve the agenda.

25. <u>Delegations – Matters on Council Agenda</u>

When a person wishes to speak to Council on a matter already on a Council Agenda, for which a hearing is not required, that person shall notify the Administrator by utilizing the following methods;

(a) Delivered personally;

(b) Request sent by ordinary mail, telephone or voice mail, facsimile or electronic mail or similar method. The notice shall include the following:

(i) the name and correct mailing address of the spokesperson;

(ii) telephone number where the representative of the delegation can be reached during the day;

(iii) originally signed, except when submitted by telephone, voice mail, facsimile or e-mail; and

(iv) clearly setting out the subject matter to be discussed and the request being made of Council.

A request to speak to Council pursuant to Subsection 25.1 must be received by the 25.2 Administrator no later than the agenda deadline in order to be included on the Council

In the event that a delegation makes an application to the Administrator after the 25.3 agenda deadline, regarding a subject which is on the agenda, the Administrator will bring the request to the attention of Council:

(a) Delegations will be advised by the Administrator that they may not be heard by Council unless the majority of members vote to allow the delegation to speak.

Delegations speaking before Council shall address their remarks to the stated 25.4 business:

(a) Delegations will be limited to speaking only once; and

(a) Rebuttal or cross debate with other delegations shall not be permitted.

A maximum of 30 minutes shall be allotted for each delegation to present his or her 25.5 position of support or opposition.

When a delegation has been invited by Council the 30 minute maximum does not 25.6 apply.

Where there are numerous delegates taking the same position on a matter, they are 25.7 encouraged to select a spokesperson to present their views:

(a) Delegations are encouraged not to repeat information presented by an earlier delegation.

(b) The Reeve shall at the conclusion of 30 minutes, inform the delegation that the time limit is up.

(c) Only upon a motion to extend the 30 minute limitation adopted by a majority of members shall the 30 minute limit be extended.

(d) Delegations will not be permitted to assume any unused time allocated to another delegation.

Upon the completion of a presentation to Council by a delegation, any discourse 25.8 between members and the delegation shall be limited to members asking questions for clarification and obtaining additional, relevant information only:

(a) Members shall not enter into debate with the delegation respecting the CAMS

presentation; and



(b) Once a motion has been moved, no further representation or questions of the delegation shall be permitted.

26. Delegations - Matters not on Council Agenda

When a person wishes to speak to Council on a matter not on a Council Agenda, for which a hearing is not required, that person shall notify the Administrator in writing, which notice shall include the following:

(a) the name and correct mailing address of the spokesperson;

(b) telephone number where the representative of the delegation can be reached during the day;

(c) originally signed, except when submitted by facsimile or e-mail; and,

- (d) clearly setting out the subject matter to be discussed and the request being made of Council.
- A request to speak to Council pursuant to Subsection 26.1 must be received by the 26.2 Administrator no later than the agenda deadline to be included on the agenda.
- The Administrator, who shall consult with the Reeve, may refuse to accept a request 26.3 to speak to Council if Council has, within the six (6) months immediately preceding the request, already heard from the person and dealt with the same or substantially the same matter by resolution or bylaw.

If a request to speak to Council is refused pursuant to Subsection 26.3, a copy of the 26.4

request and reply, shall be forwarded to members by the Administrator.

In the event that a delegation makes an application to the Administrator after the 26.5 agenda deadline, regarding a subject which is not on the agenda, the Administrator will bring the request to the attention of Council.

(a) Delegations will be advised by the Administrator that they may not be heard by Council unless the majority of members vote to allow the delegation to speak.

27. Reeve, Division, Committee, Foreman & Administrator Reports

27.1 Statements shall include the sharing of the following information:

(a) events, activities or community functions attended; and

(b) general work of members on behalf of Council colleagues, constituents and the Municipality.

All comments will be verbal only and shall not be recorded in the minutes of the 27.2 meeting.

28. Bylaws

Every proposed bylaw must have three (3) distinct and separate readings. 28.1

A proposed bylaw must not have more than two (2) readings at a Council Meeting 28.2 unless the members present unanimously agree to consider third reading.

A proposed bylaw will be considered by Council immediately following consideration 28.3 of the report or item to which the bylaw relates.

Only the title or identifying number has to be read at each reading of the bylaw. 28.4

Each member present at the meeting at which first reading is to take place must be 28.5 given or have had the opportunity to review the full text of the proposed bylaw before the bylaw receives first reading.

Each member present at the meeting at which third reading is to take place must, 28.6 before the proposed bylaw receives third reading, be given or have had the opportunity to review the full text of the proposed bylaw and of any amendments that were passed after first reading.

When a bylaw has been given three (3) readings by Council, it: 28.7

(a) becomes a municipal enactment of the municipality; and (b) is effective immediately unless the bylaw or an applicable provincial statute provides otherwise.

The Administrator shall be empowered to correct any typographical error that may not 28.8 have been corrected at the time of submission to Council and the bylaw shall have the same status as if Council had corrected same.

After passage, every bylaw shall be signed by the Reeve and the Administrator, 28.9 pursuant to the Act and marked with the corporate seal of the Municipality.

29. Recess

The Council may recess at any time during the meeting. 29.1

A motion to recess must state the time of duration of the recess, and must be passed 29.2

by a majority of the members present.

The Council may reconvene sooner than the time mentioned in the motion of recess, 29.3 but must not reconvene later that fifteen minutes after the time specified for reconvening or the meeting shall be deemed to be adjourned due to a lack of quorum.



30. Adjournment

- All regularly scheduled Council Meetings shall stand adjourned when the Council has completed all business as listed on the order of business or upon the arrival of 4:00 30.1 pm.
- If a member is speaking upon arrival of the time mentioned in Subsection 30.1, the Reeve shall wait until that person is done speaking before asking Council to consider 30.2 whether it wants to extend the time of the meeting.
- Any business which remains on the agenda and which has not been dealt with at the time of adjournment shall be deemed to be postponed until the next regularly 30.3 scheduled Council Meeting, or until a Special Meeting is called for the purpose of dealing with the unfinished items.

31. Extension of Time

- Notwithstanding Section 30, a majority of the members present may extend a regularly scheduled Council Meeting beyond 4:00 pm by unanimous vote of all members present.
- If Council extends its meeting pursuant to Subsection 31.1, the meeting shall continue 31.2 until:
 - (a) the business of the meeting is completed;
 - (b) a motion to adjourn is passed; or
 - (c) a quorum is no longer present.

PART IV - CONDUCT AT COUNCIL MEETINGS

32. Reeve

32.1 The Reeve shall:

- (a) preside at all Council Meetings;
- (b) preserve order at Council Meetings;
- (d) enforce the rules of Council;
- (d) decide points of privilege and points of order; and

(e) advise on points of procedure.

- The Reeve shall have the same rights and be subject to the same restrictions, when 32.2 participating in debate, as all other members.
- The Reeve shall have the same rights and be subject to the same restrictions as all 32.3 other members to make a motion.

33. Deputy Reeve

- The Council shall, at its first meeting, or as soon thereafter as conveniently possible and whenever the office becomes vacant, appoint from the Councillors a Deputy Reeve who shall hold office for a term of two (2) years or for such longer period as the Council may decide, and in any event until a successor is appointed.
- If the Reeve, for any reason, is unable to perform the duties of his or her office, the 33.2 Deputy Reeve shall have all of the powers of the Reeve during the inability.

34. Acting Reeve

- Council shall, appoint a member to act as Reeve if: 34 1
 - (a) both the Reeve and the Deputy Reeve, are unable to perform the duties of his or her office; or

(b) the offices of both the Reeve and the Deputy Reeve are vacant.

- The member to be appointed, pursuant to Subsection 34.1, shall be elected by a 34.2 majority of the members present.
- Where two (2) members have an equal number of votes, the Administrator shall: 34 3
 - (a) write the names of those members separately on blank sheets of paper of equal size, colour and texture;
 - (b) fold the sheets in a uniform manner so the names are concealed;
 - (¢) deposit them in a receptacle; and
 - (d) direct a person to withdraw one (1) of the sheets.
- The member whose name is on the sheet withdrawn pursuant to Subsection 34.3(d) 34.4 shall be declared elected.

35. Persons Allowed at the Table

No person, except members, the Administrator and other staff as authorized by the Council are permitted to be seated at the council table during sittings of Council without permission of Council.

36. Conduct of Public

36.1 All persons in the public gallery at a Council Meeting shall:

(a) refrain from addressing Council or a member unless permitted to do so;

(c) refrain from disturbing the proceedings by words, gestures or actions including applauding, displaying flags, placards or similar material;

(d) refrain from talking on cellular telephones;

(e) refrain from making audio or video recordings of council proceedings; and

(f) ensure that all electronic devices are silent and operated in such a manner that does not interfere with the meeting or with another person's ability to hear or view the proceedings.

37. Conduct of Delegations

When addressing members at a Council Meeting, a delegation shall refrain from: 37.1

(a) speaking disrespectfully of the federal government, the provincial government or another municipal council, or any official representing them;

(b) using offensive words in referring to a member, an employee of the municipality or

(c) shouting or using an immoderate tone, profane, vulgar or offensive language; and

(d) refrain from making audio or video recordings of council proceedings;

Members of Council wishing to speak at a meeting shall ensure they do not interrupt 38. Conduct of Members 38.1

If more than one member wishes to speak at a meeting at the same time, the Reeve shall indicate which member shall speak first. 38.2

When addressing a Council Meeting, a member shall refrain from: 38.3

(a) speaking disrespectfully of the federal government, the provincial government or another municipal council, or any official representing them;

(b) using offensive words in referring to a member, an employee of the municipality or

(c) reflecting on a vote of Council except when moving to rescind or reconsider it,

(d) reflecting on the motives of the members who voted on the motion or the mover of

(e) shouting or using an immoderate tone, profane, vulgar or offensive language.

38.4 When a member is addressing the Council, all other members shall:

(b) refrain from interrupting the speaker, except on a point of order or point of

(c) refrain from carrying on a private conversation in such a manner that disturbs the

Members shall ensure that all electronic devices remain silent and do not interfere with 38.5

That should a perceived conflict of interest be brought forth, by a member of Council or the Administrator, that all members of Council be allowed to voice their opinions in 38 6 an open and free manner as to why the conflict may exist or explain why there is not

If there is a failure to resolve the issue to the satisfaction of all Council, then the member bringing forth the perceived conflict of interest shall call for a Point of Order 38.7 (Section 41) and request a recorded vote (Section 64).

The Reeve may request that any person in the public gallery who disturbs the 39. Improper Conduct proceedings of Council or acts improperly at a Council Meeting, as set out in Section 36, leave or be expelled from the meeting.

The Reeve may request that any delegation who addresses Council improperly as set out in Section 37, leave or be expelled from the meeting. 39 2

No person shall refuse to leave a Council Meeting when requested to do so by the 39.3

Any person who refuses to leave when requested to do so may be removed.

If a person disturbs the proceedings of Council or refuses to leave when requested to 39.4 do so, the Reeve may recess the meeting until the person leaves or adjourn the 39.5 meeting to another day

The Reeve may direct that law enforcement officials be engaged to assist in the removal of the person in the gallery or any delegation acting improperly. 39.6

AL ON



40. Leaving the Meeting

Every member who leaves the Council Meeting before the meeting is over, whether 40.1 intending to return to the meeting or not, shall notify the Administrator.

The Administrator shall make a notation in the minutes of the name of any member 40.2 leaving the meeting pursuant to Section 40.1, and the time the member did so and if the member returns the time they returned.

41. Point of Order

A member may rise and ask the Reeve to rule on a Point of Order. 41.1

When a Point of Order is raised, the member speaking shall immediately cease 41.2 speaking until the Reeve decides the Point of Order raised.

A Point of Order must be raised immediately at the time the rules of Council are 41.3 breached.

The member against whom a Point of Order is raised may be granted permission by 41.4 the Reeve to explain.

The Reeve may consult the Administrator before ruling on a Point of Order. 41.5

A Point of Order is not subject to amendment or debate. 41.6

42. Point of Privilege

A member may rise and ask the Reeve to rule on a Point of Privilege. 42 1

After the member has stated the Point of Privilege, the Reeve shall rule whether or not 42.2 the matter raised is a Point of Privilege.

If the matter is determined to be a Point of Privilege, the member who raised the Point 42.3 of Privilege shall be permitted to speak to the matter.

If the Point of Privilege concerns a situation, circumstance or event which arose 42.4 between Council Meetings, the member shall raise the Point of Privilege immediately after approval of the minutes of the previous Council Meeting.

The Reeve may consult the Administrator before ruling on a Point of Privilege. 42.5

A Point of Privilege is not subject to amendment or debate unless a motion regarding 42.6 the Point of Privilege is put to Council.

43. Point of Procedure

Any member may ask the Reeve for an opinion on a Point of Procedure. 43.1

When a Point of Procedure is raised, the member speaking shall immediately cease 43.2 speaking until the Reeve responds to the inquiry.

After the member has asked the Point of Procedure, the Reeve shall provide an 43.3 opinion on the rules of procedure bearing on the matter before Council.

The Reeve may consult the Administrator before providing an opinion on the Point of 43.4 Procedure.

A Point of Procedure is not subject to amendment or debate. 43.5

The Reeve's answer to a Point of Procedure is not a ruling, and cannot be appealed 43.6 to the whole of Council.

44. Appeal

Whenever a member wishes to appeal any ruling of the Reeve or a Point of Order or 44.1 Point of Privilege to the whole of Council:

(a) the motion of appeal, "that the decision of the chair be overruled" shall be made;

(b) the member may offer a brief reason for the challenge;

(c) the Reeve may state the reason for the decision; and

(d) following which the question shall be put immediately without debate.

The Reeve shall be governed by the vote of the majority of the members present. 44.2

A ruling of the Reeve must be appealed immediately after ruling is made or the ruling 44.3 will be final.

45. Calling a Member to Order

When the Reeve calls a member to order, the member shall resume his or her seat, but may afterwards explain his or her position in making the remark for which he or she was called to order.

In the event that a member refuses to resume his or her seat when called to order, the 45.2 Reeve shall request the Deputy Reeve, or if the Deputy Reeve is absent or is the unruly member, any other member of Council to move a resolution to remove the unruly member either:

(a) for the balance of the meeting,

(b) until a time, which shall be stated in the motion, which cannot continue beyond the current meeting; or It was



(c) until the member makes an apology acceptable to Council for his or her unruly behavior, whichever shall be the shortest time.

When the majority of Council votes in favour of the resolution, the Reeve shall direct the unruly member to leave the Council Chamber, and if the member refuses to leave, the Reeve may:

(a) recess the meeting until the person leaves or adjourn the meeting to another day;

or

(b) direct that law enforcement officials be engaged to assist in the removal of the

unruly member.

When Council has directed an unruly member to leave the Council Chambers pursuant to Subsection 45.3, and the member makes an explanation and apology adequate and satisfactory to the Council, it may, by a majority vote of the remaining members present, allow the offending member to remain in his or her place if he or she has not left or been removed.

PART V - MOTIONS

46. Motions and Debate

46.1 A motion shall express fully and clearly the intent of the mover and shall not be preceded by any preamble or whereas clauses.

46.2 A motion may be made in the following two manners:

- (a) The motion may be made by the member following a discussion and/or debate concerning the issue at hand. Because the issue is discussed in length before the motion is made, this procedure generally allows for the reduced necessity of amendments.
- (b) The motion may be made by the member prior to the discussion and/or debate. This procedure allows for the member(s) to make a statement concerning their stand on an issue and bring the discussion and/or debate to that point of conclusion. The remaining Subsections of 46.3 to 46.5 are related to debating a motion

Any member may require the motion under debate to be read at any time during the debate, but not so as to interrupt a member while speaking.

When a motion is under debate no other motion may be made, except a motion to:

(a) amend a motion;

(b) refer motion to a Council Committee or administration for a report back to Council;

(c) postpone a motion to a fixed date;

- (d) request that a motion be put to a vote;
- (e) extend the time for a Council Meeting; or

(f) adjourn the meeting.

Notwithstanding any other provisions of this Bylaw, the member, who moved a motion after a motion is under debate, may, with the consent of Council:

(a) on his or her own initiative while he or she is speaking on the same; or

(b) when requested by another member speaking on the motion; change the wording of the motion, or agree to a change proposed by another member, if the alteration does not change the intention of the motion.

46.6 Any motions allowed under Subsection 46.4 shall be considered in the order in which they were moved.

47. Motion to Amendments

- 47.1 Except as provided in Subsection 47.12, any motion may be amended to:
 - (a) add words within the motion;
 - (b) delete words within the motion; or
 - (c) change a word or words within the motion.
- 47.2 The amending motion must be:
 - (a) relevant to the main motion;
 - (b) made while the main motion is under consideration; and

(c) consistent with the principle embodied in the main motion.

- 47.3 An amending motion may also be amended (also called a sub amendment).
- 47.4 A sub amendment must be:
 - (a) relevant to the original amendment;

(b) made while the original amendment is under consideration; and

(c) consistent with the intent of either the original amendment or the main motion.

Only two (2) amendments to a motion (an amendment and a sub amendment) are allowed at the same time. When one or both have been dealt with, a further amendment or sub amendment may be entertained.



- There is no limit to the number of amendments or sub amendments that may be 47.6 proposed.
- An amendment may be introduced at any stage before the question is put on the main motion provided there is not more than one amendment and one sub amendment 47.7 before the meeting at one time.
- Any member wishing to move an amendment that is not in order at the time because there are already two amendments before the meeting may state the intention of the 47.8 proposed amendment, as the proposal may affect the vote on those motions awaiting
- The main motion shall not be debated until all amendments to it have been put to a 47.9
- 47.10 Amendments shall be put in the reverse order to the order in which they were moved.
- 47.11 When all amendments have been voted on, the main motion incorporating all amendments adopted shall be put to a vote.
- 47.12 No amendments shall be made to the following motions:
 - (a) a motion to adjourn;
 - (b) a motion to defer to a fixed date, except as to the date; and
 - (c) a motion requesting that a motion be put to a vote.

48. Dividing a Motion into Parts

- A member may request or the Reeve may direct that a motion be divided if the motion contains more than one separate and complete recommendation. 48.1
- Council shall then vote separately on each recommendation. 48 2
- A new motion to add a further recommendation is permitted provided: 48.3
 - (a) the proposed recommendation is relevant to the original motion;
 - (b) the proposed recommendation does not alter in a significant way the principle embodied in the original motion; and
 - (c) the original motion has been dealt with.

49. Motion Arising

- When a particular matter is before Council, a motion arising on the same matter is 49 1 permitted provided:
 - (a) the proposed motion is related to and rises from the item which has just been considered;
 - (b) the proposed motion does not alter in a significant way the principle embodied in the original motion; and
 - (c) the proposed motion is made before the consideration of any other item of business at the meeting.

50. Request that Motion be put to Vote

- A motion requesting that a motion be put to a vote shall not be moved by a member 50.1 who has spoken to the original motion.
- A motion requesting that a motion be put to a vote shall not be amended or debated. 50.2
- If a motion requesting that a motion be put to a vote is passed by Council, the original motion shall immediately be put to a vote of Council without any amendment or debate. 50.3
- If a motion requesting that a motion be put to a vote is not passed by Council, the 50 4 original question may be amended or debated.

51. Motion to Adjourn

- A member may move a motion to adjourn a meeting at any time, except when: 51.1
 - (a) another member is in possession of the floor;
 - (b) a call for a recorded vote has been made;
 - (c) the members are voting;
 - (d) Council is considering a motion requesting that a motion be put to a vote; or
 - (e) a previous motion to adjourn has been defeated and no other intermediate proceeding has taken place.
- 51.2 A motion to adjourn shall be decided without debate.

52. Motion to Move to a Closed Meeting

- A member may make a motion that a Council Meeting move to a closed meeting. 52 1
- The motion to move to a closed meeting must: 52.2
 - (a) be in accordance with The Local Authority Freedom of Information and Protection of Privacy Act;
 - (b) include in general terms the subject of the item(s) to be discussed; and
 - (c) include the reason for the Council Meeting to be held in a closed meeting.



52.3 No bylaw or resolution shall be passed during a closed meeting.

53. Motion Contrary to Rules

The Reeve may refuse to put to Council a motion which is, in the opinion of the Reeve, 53.1 contrary to the rules and privileges of Council.

54. Withdrawal of Motions

The mover of a motion may withdraw it at any time prior to a vote being taken or prior 54 1 to the motion being amended.

55. Motion to Reconsider

- A motion to reconsider shall apply to resolutions only, and shall not apply to bylaws 55.1 passed by Council.
- A motion to reconsider is in order whether the original motion passed or defeated. 55.2
- A motion to reconsider may only be made at the same Council Meeting as the original 55.3 motion was considered.
- A motion to reconsider must be moved by a member who voted on the winning side of 55.4
- When a motion loses on a tied vote, the winning side is those who voted against the 55.5
- A motion to reconsider is debatable only if the motion being reconsidered is debatable. 55.6
- A motion to reconsider cannot be amended.
- A motion to reconsider shall require a majority vote of the members present at the 55.7 55.8
- If a motion to reconsider is adopted, the original motion is immediately placed before 55.9 Council to be reconsidered.
- 55.10 Once a vote on a motion to reconsider has taken place, there shall be no further motion to reconsider that resolution.

56. Motion to Rescind

- A motion to rescind shall apply to resolutions only, and shall not apply to bylaws 56.1 passed by Council.
- A motion to rescind is in order only when the original motion passed. No motion to 56.2 rescind shall be necessary when the original motion failed.
- A motion to rescind may be made at any time following the Council Meeting at which 56.3 the original motion was voted on regardless of the time that has elapsed since the original vote was taken.
- A motion to rescind may be moved by any Council Member regardless how they voted 56.4 on the original motion.
- A motion to rescind is debatable. 56 5
- A motion to rescind may be amended. 56.6
- A motion to rescind shall, in all cases, require a majority vote of all Council Members 56.7 to pass.
- A motion cannot be rescinded: 56.8
 - (a) when the making or calling up of a motion to reconsider is in order;
 - (b) when action on the motion has been carried out in a way that cannot be undone;
 - (c) when a resignation has been accepted or actions electing or expelling a person from membership or office have been taken.

57. Motion to Postpone

- Where a majority of all members decide to postpone a motion to a fixed date, the motion cannot be considered by Council until the fixed date.
- Notwithstanding Subsection 57.1, Council may consider a postponed motion before 57.2 the fixed date if a majority of members agree that the motion may be considered before that date.
- The only amendment allowed to a motion to postpone to a fixed date is to change the 57.3 date.

58. Motion to Refer

- A motion to refer a matter shall not be amended or debated except with respect to the 58.1 conditions of the referral or the time required to carry out the review.
- A member making a referral motion generally should include in the motion: 58 2
 - the terms on which the motion is being referred; and (a)
 - the time when the matter is to be returned. (b)

59. Debate on Motion

No member shall speak more than once to a motion, until each member has been provided an opportunity to speak on the motion, except to explain a material part of their speech which may have been misquoted or misunderstood.

The mover of the motion shall be given the first opportunity to speak. 59.2

The mover of the motion shall be allowed a reply at the conclusion of the debate. 59.3

60. Legal Advice

Where a majority of the members present at a Council Meeting wish to receive legal 60.1 advice in private, Council may recess for a period of time sufficient to receive legal

61. Voting of council

- A member attending a Council Meeting shall vote at the meeting on a matter before 61.1 Council unless the member is required to abstain from voting pursuant to the Act or
- If a member is not required to abstain from voting on a matter before Council pursuant 61.2 to Subsection 61.1 and abstains from voting, the Council Member is deemed to have voted in the negative.

The Administrator shall ensure that each abstention is recorded in the minutes of the 61.3 meeting.

The Reeve shall vote with the other members on all questions unless the Reeve is 61.4 required to abstain from voting pursuant to the Act or any other Act.

62. Majority Decision

Unless a greater percentage of votes is required by any provision of this Bylaw, at every Council Meeting, all questions are to be decided by a majority vote of the members present.

63. Recorded Vote

- Before a vote is taken by Council, a member may request that the vote be recorded. 63.1
- If a vote is recorded, the minutes must show the names of the members present and 63.2 whether each voted for or against the proposal or abstained.

64. Tied Vote

If there are an equal number of votes for and against a resolution or bylaw, the 64.1 resolution or bylaw is defeated.

PART VI - COMMITTEES

65. Procedure for Appointments and Terms

- Every two (2) years, after the general election, Council shall review appointments to 65.1 Council Committees.
- The appointments to Council Committees shall be for a two (2) year term beginning 65.2 on the first meeting of Council after the next general election.
- Notwithstanding Subsection 65.2 in a general election year, the term of appointment 65.3 shall be reduced to coincide with the day of election.

Appointees may be reappointed from term to term with no maximum number of terms 65.4 on one particular Council Committee.

- The Administrator shall advise Council of any Council Committee Members absent for 65.5 more than two (2) meetings within a calendar year and request that a written warning be forwarded to the member. As well, if the member misses three (3) meetings within a calendar year Council shall be advised to decide if the member should be removed from the Council Committee.
- The Council may at its discretion revoke the membership of any individual who has 65.6 been appointed to a Council Committee.

66. Committee Procedures

- Council may from time to time establish a Committee in response to specific issues 66.1 requiring immediate or long term attention.
- The membership and jurisdiction of a Committee shall be as provided for in the 66.2 enabling legislation or as directed by Council.
- The Reeve is an ex-officio voting member of all Committees established by Council 66.3 pursuant to the Act, unless Council provides otherwise, and when in attendance, possesses all of the rights, privileges, powers and duties of other members, whether If we elected or appointed.



- The Reeve's attendance shall not, however, be included for the purpose of determining 66.4 a quorum.
- Municipal Administration shall act only in an advisory capacity to Committees of 66.5 Council and shall not be considered voting members or have any voting privileges in respect to participation on any Committee appointment.
- The chair of all Committees established by Council shall be designated by Council, 66.6 unless Council directs otherwise.
- All Councillors may attend the meetings of Committees established pursuant to the Act, and may take part in the proceedings of the same, except that non-committee 66.7 members shall not have a vote.
- Each Committee shall meet as soon as possible after it has been appointed and where a chair has not been appointed by Council, members of that Committee shall select a 66.8 chair and vice-chair, and if required, decide the day and time for holding its regular
- The chair shall preside at every meeting, participate in the debate and shall vote on all 66.9 motions.
- In the absence of the chair, the vice-chair shall preside, and in the absence of both the chair and the vice-chair, one (1) of the other members of the Committee shall be 66.10 elected to preside, and shall discharge the duties of the chair during the meeting or until the arrival of the chair or Vice-chair.
- 66.11 An act or proceeding of a Committee is not effective unless it is authorized or adopted by a resolution at a duly constituted public Committee Meeting.
- 66.12 The public has the right to be present at Committee Meetings that are conducted in public unless the chair expels a person for improper conduct.
- 66.13 Subject to Subsection 66.14, Committees shall conduct all Committee Meetings in
- 66.14 Committees may close all or part of the meeting if the matter to be discussed is within one (1) of the exemptions in Part III of The Local Authority Freedom of Information and Protection of Privacy Act.
- 66.15 Notice of regularly scheduled Committee Meetings is not required to be given.
- 66.16 If a Committee changes the date, time or place of a regularly scheduled meeting, the Secretary shall give at least twenty-four (24) hours' notice of the change to:
 - (a) any members of the Committee not present at the meeting at which the change was made; and
 - (b) the public.
- 66.17 Notwithstanding Subsection 66.16, a Committee Meeting may be held with less than twenty-four (24) hours' notice to all members and without notice to the public if all Committee Members agree to do so, in writing, immediately before the beginning of
- 66.18 The consent to waive notice of a change in date, time or place of a meeting pursuant to Subsection 66.17 may be given in person or by facsimile, electronic mail and other similar means.
- 66.19 If a Committee cancels its regularly scheduled meeting, the Secretary of the Committee shall give at least twenty-four (24) hours' notice of the change to:
 - (a) all members not present at the meeting at which the decision to cancel was made; and
 - (b) the public.

- 66.23 Committees may at its discretion hold its meetings electronically in accordance with Subsection 8 of this Bylaw.

 - c) compile all applications and provide the complied applications to Council for appointment consideration.

68. Terms

- Appointments to Other Bodies shall be for a two (2) year term beginning on the date 68.1 of appointment until the first meeting of Council after the next General Election.
- Notwithstanding Subsection 68.1, in a general election year, the term of appointments 68 2 of Council Members shall be reduced to coincide with the day of the election.

Council appointees may be reappointed from term to term with no maximum number 68.3 of terms on particular Other Body.

The Administrator or Secretary shall advice Council of any members absent for more than two (2) meetings within a calendar year and request that a written warning be 68.4 forwarded to the member. As well, if the member misses three (3) meetings within a calendar year, Council shall be advised to decide if the member should be removed from the Other Body.

Council may in its discretion revoke the membership of any individual who has been 68 5

appointed to an Other Body.

69. Other Body Procedures

Council may from time to time establish Other Bodies in response to specific issues 69.1 requiring immediate or long-term attention.

The membership and jurisdiction of Other Bodies shall be as provided for in the 69.2 enabling legislation or as directed by Council.

The Reeve is an ex-officio voting member of all Other Bodies established by Council pursuant to the Act unless Council provides otherwise, and when in attendance, 69.3 possesses all the rights, privileges, powers and duties of other members whether elected or appointed.

The Reeve's attendance shall not, however, be included for the purpose of determining 69.4

Municipal Administration shall act only in an advisory capacity to Other Bodies and 69.5 shall not be considered voting members or have any voting privileges.

The chair of all Other Bodies established by Council shall be designated by Council, 69.6 unless Council directs otherwise.

- All Councillors may attend the meetings of Other Bodies established pursuant to the 69.7 Act, and may take part in the proceedings of the same, except that non-appointed Councillors shall not have a vote.
- Each Other Body shall meet as soon as possible after it has been appointed and where 69.8 a chair has not been appointed by Council, members of that Other Body shall select a chair and vice-chair, and if required, decide the day and time for holding its regular meetings.

The chair shall preside at every meeting, participate in the debate and shall vote on all 69.9

- 69.10 In the absence of the chair, the vice-chair shall preside, and in the absence of both the chair and the vice-chair, one (1) of the other members shall be elected to preside, and shall discharge the duties of the chair during the meeting or until the arrival of the chair or Vice-chair.
- 69.11 An act or proceeding of an Other Body is not effective unless it is authorized or adopted by a resolution at a duly constituted public Other Body Meeting.
- 69.12 The public has the right to be present at Other Bodies' meetings that are conducted in public unless the chair expels a person for improper conduct.

69.13 Subject to Subsection 69.14, Other Bodies shall conduct all meetings in public.

69.14 Other Bodies may close all or part of the meeting if the matter to be discussed is within one (1) of the exemptions in Part III of The Local Authority Freedom of Information and Protection of Privacy Act.

69.15 Notice of regularly scheduled meetings is not required to be given.

69.16 If an Other Body changes the date, time or place of a regularly scheduled meeting, the Secretary shall give at least twenty-four (24) hours' notice of the change to: (a) any members not present at the meeting at which the change was made; and (b) the public.

69.17 Notwithstanding Subsection 69.16, a meeting may be held with less than twenty-four (24) hours' notice to all members and without notice to the public if all members agree

to do so, in writing, immediately before the beginning of the meeting.

69.18 The consent to waive notice of a change in date, time or place of a meeting pursuant to \$ubsection 69.17 may be given in person or by facsimile, electronic mail and other similar means.
